...but controversy dogs appointment

THE DECISION to name Carole Mills as the new chief executive of Milton Keynes Council has not been without controversy.

As well as an interview by the council's cross-party Appointment Panel, she and three other candidates were earlier interviewed by separate panels made up respectively of senior business figures, council employees and community leaders.

The business panel unanimously did not recommend Ms Mills, Business MK has learned, nor did they recommend any other candidate.

One panel member expressed "disappointment" at her appointment.

The panels' role was to comment on the candidates and to highlight any issues for the Appointment Panel to probe further at final interview, said a council spokesman.

The final decision on which candidate to recommend was made by the Member Appointment Panel, which included the three group leaders.

The business panel, whose remit did not include due diligence nor references, raised with Ms Mills an investigation at Nottingham City Council when she was deputy chief executive and chief finance officer into the management of a £12 million

Future Jobs Fund, Business MK has been told.

Milton Keynes Council said in a statement that the issues "were historic, were not directly Carole's responsibility and were satisfactorily dealt with by Nottingham City Council at the time.'

In a joint statement, group leaders Andrew Geary, Peter Marland and Douglas McCall said: "Carole Mills was appointed after a rigorous recruitment process, which involved an Executive Search and selection process undertaken by an independent third party and reference checks with her current and previous employers, as well as an intensive twoday final selection programme that incorporated panel sessions with a range of stakeholders, presentations to members of the council and final interviews with a crossparty Appointment Panel.

"All three group leaders - along with the other members of the Appointment Panel were united in their feeling that Carole was by far and away the best candidate. That has not changed, we remain confident that we made the right choice, and we are still 100 per cent behind Carole's appointment.

"She was clearly the right candidate for the iob."
